Australian Federal Budget 2020-21

On 8 October 2020, Federal Health Minister Greg Hunt handed down \$115.5 billion for health, aged care and sport through the 2020–21 Budget, with the portfolio seeing an additional \$32 billion in funding over the next four years. Palliative Care Australia has kindly collated a list of the key palliative medicine, aged care and grief and bereavement initiatives announcements:

- Greater Choice for at Home Palliative Care program: \$3.6 million will support access to end-of-life care for Australians, regardless of where they live, including in residential aged care facilities.
- 23,000 new home care places: \$1.6 billion will help older Australians live at home for longer through providing an additional 23,000 home care places. Increase of 73,105 places since May 2018.
- Implementation of AN-ACC funding model: \$91.6 million will fund the second stage in the implementation of the new Australian National Aged Care Classification system (\$91.6 million). This "will enable independent assessments to deliver more accurate funding to meet the care needs of residents".
- Aged care workforce reform: \$19 million including \$10.8 million for nursing skills and competence and \$9 million for the Aged Care Quality Safety Commission.
- Grief and Bereavement: \$12.5 million to provide increased availability of grief and trauma support services to assist aged care residents and their families who have experienced a COVID-19 outbreak (more details below).

AUS: Minister announces details on the grief and trauma support for Australia's aged care sector

The Australian Government is investing \$12.4 million in a Grief and Trauma Response Package to ensure support is available for those affected by COVID-19 across the aged care sector. On 14 October 2020, Minister for Aged Care and Senior Australians, Richard Colbeck, said services would be established as quickly as possible to ensure people were able to access the support they need. It will be delivered by Australian Centre for Grief and Bereavement, Phoenix Australia – Centre for Posttraumatic Mental Health and Dementia Support Australia. AUS: Royal Commission into Aged Care Quality and Safety releases 'Aged care and COVID-19: a special report' On 1 October 2020 the Royal Commission into Aged Care Quality and Safety released its special report on 'Aged care and COVID-19'. The report is the result of a hearing of the Royal Commission into the impact of COVID-19 on aged care, which was held in Sydney from 10 to 13 August 2020. It makes six recommendations, among them, a requirement that the Australian Government report to the Australian Parliament no later than 1 December 2020 on the progress of their implementation. AUS: TGA provides new communication materials on access pathways for medicinal cannabis in Australia Therapeutic Goods Administration (TGA) has developed a new set of communication materials to help consumers and health professionals understand access pathways for medicinal cannabis in Australia. SA: Palliative Care Experience Survey 2020

AIHW: BreastScreen Australia monitoring report 2020 and Cancer screening and COVID-19 in Australia

The number of cancer screening tests performed as part of national population screening programs declined during the first few months of the COVID-19 pandemic in Australia, according to a new report from the Australian Institute of Health and Welfare (AIHW). The report, *Cancer screening and COVID-19 in Australia*, brings together data for the period of January to June 2020 on the 3 national cancer screening programs — BreastScreen Australia, the National Cervical Screening Program, and the National Bowel Cancer Screening Program. AlHW public consultation on the draft National Palliative Care and End-of-Life Care Information Priorities A newly released paper will help to guide efforts in palliative care and end-of-life care information development over the next 10 years. Providing a vision for the future of national palliative care and end-of-life care information, it will be the first of its kind in the palliative care and end-of-life care sector. The consultation draft of the National Palliative Care and End-of-Life Care Information Priorities was developed by the Palliative Care and End-of-Life Care Data Development Working Group (PC EOL WG), a subcommittee reporting to the Australian Health Ministers Advisory Council (AHMAC)'s Health Services Principal Committee (HSPC). New RACP Pomegranate Health episode: Ep63: the WHO's biggest test

During the COVID-19 crisis there has been some criticism of the World Health Organisation as to whether it declared a pandemic soon enough or covered up for China's failings. But few commentators have explained the role and responsibilities the WHO shares with its member states in dealing with a pandemic. A prototype of the International Health Regulations were conceived during the cholera epidemics of the mid 1800s, and but the most current version of the IHR was formalised in 2005 in response to SARS. Associate Professor Adam Kamradt-Scott has documented the political and social factors that have accompanied the implementation of the IHR. ARTICLE: McDougall RJ, Gillam L, Ko D, et al: Balancing health worker well-being and duty to care: an ethical approach to staff safety in COVID-19 and beyond

Journal of Medical Ethics |Online 25 September 2020 – Abstract: The COVID-19 pandemic has highlighted the risks that can be involved in healthcare work. In this paper, we explore the issue of staff safety in clinical work using the example of personal protective equipment (PPE) in the COVID-19 crisis. We articulate some of the specific ethical challenges around PPE currently being faced by front-line clinicians, and develop an approach to staff safety that involves balancing duty to care and personal well-being. We describe each of these values, and present a decision-making framework that integrates the two. The aim of the framework is to guide the process of balancing these two values when staff safety is at stake, by facilitating ethical reflection and/or decision-making that is systematic, specific and transparent. It provides a structure for individual reflection, collaborative staff discussion, and decision-making by those responsible for teams, departments and other groups of healthcare staff. Overall the framework guides the decision maker to characterise the degree of risk to staff, articulate feasible options for staff protection in that specific setting and identify the option that ensures any decrease in patient care is proportionate to the increase in staff well-being. It applies specifically to issues of PPE in COVID-19, and also has potential to assist decision makers in other situations involving protection of healthcare staff. ARTICLE: Information sharing challenges in end-of-life care: A qualitative study of patient, family and professional perspectives on the potential of an electronic palliative care co-ordination system

BMJ Open | Online – 5 October 2020 – There are only a limited number of qualitative studies exploring attitudes towards and use of an electronic palliative care co-ordination system (EPaCCS). The findings of this study support those of a recent systematic review that identified the burden of inputting data and information technology (IT) systems as the main challenge to implementation of EPaCCS. A key finding of this study was that introduction of an EPaCCS alone does not provide a solution to some of the current difficulties regarding interdisciplinary management of end-of-life (EoL) patients in the community. An EPaCCS will only facilitate access to patient information, the utility of which is largely dependent on its quality; improving access to advance care planning (ACP) documentation is not going to improve care if the information recorded within them is of poor quality or insufficient detail or has not been completed. This demonstrates a need for investment in training for health and social care professionals in ACP discussions and documentation

to instill confidence and improve quality. This article highlights concerns regarding the infrastructure required to support an EPaCCS including: demand on already stretched professionals, technology provision required to enable access and continued support to ensure the system is updated. Ensuring appropriate infrastructure is in place has emerged as a challenge in the implementation of coordinated records for EoL patients in the U.K. and U.S. contexts.
